## MODIFIED EVENT CODES

More functionality was added to this event code to ensure it is only used when amending Schedules, D, E and F.

BK - Other > **Amendment - Amended Schedules D, E, F for Ch 7, 11 & 13 (fee)**

The functionality of this event code has been modified as follows:

- 1) A message has been added informing the users that this event is for filing amendments to Schedules D, E and F ONLY;
- 2) Check boxes have been added to select the specific schedule(s) being amended

The event code was modified to add “/Disgorgement” language to the event code.

## NEW EVENT CODES FOR TRUSTEES

LBR Form: Task 112A - F 2016-2.2.DISBURSEMENT

## MODIFIED EVENT CODE FOR TRUSTEES

Only the functionality of this event code was modified.

BK - Trustee/US Trustee > **Notice of Assets Filed by Trustee and Court’s Notice of Possible Dividends (BNC)**

The functionality of this event code has been modified to set claims deadlines for creditors and government entities. This option was previously removed as the Government claim bar date was not calculated accurately.

#### **MOVED EVENT CODES FROM “BK - Motions/Applications menu to BK - Trustee/US Trustee menu**

The following event codes were moved from the BK - Motions/Applications menu to display under the BK - Trustee/US Trustee menu options

BK - Trustee/US Trustee > **Sanctions for Debtor’s Attorney Misconduct under Rule 9011 – Misconduct of Attorney (motion)**

BK - Trustee/US Trustee > **Fine and/or disgorgement of fees against bankruptcy petition preparer (motion)**

BK - Trustee/US Trustee > **Disgorge attorney’s fees under 11 U.S.C. section 329 by U.S. Trustee (motion)**
