This tournament honors Earle Hagen and his legacy of service to the bankruptcy community in the Central District of California. A respected fixture of the bankruptcy bar for over 40 years, Earle maintained an active bankruptcy practice while also serving the larger community. He was not only one of the founders of the Bankruptcy Study Group, which later became the Los Angeles Bankruptcy Forum, but he also always had time to mentor younger attorneys.
